#### Simplex Infra announces audited FY18 results

Kolkata, May 31, 2018 – Simplex Infra has announced its audited Standalone and Consolidated Results for the Quarter and year ended March'18

During FY18 the Standalone Revenue from Operations stands at ₹ 5766 cr against ₹ 5608 cr last year. It has earned during the year an EBITDA of ₹ 805 cr against ₹ 778 cr last year, EBIT of ₹ 622 cr (₹ 580 cr), PBT ₹ 151 cr (₹ 135 cr) and PAT 117 cr (₹ 120 cr).

During the Q4 of FY18 the Company registered standalone revenue from operations of ₹ 1648 cr (₹ 1550 cr), EBITDA ₹ 209 cr (₹ 211 cr), EBIT ₹ 165 cr (₹ 162 cr), PBT ₹ 40 cr (₹ 49 cr) and PAT of ₹ 29 cr (₹ 67 cr),

The Consolidated Income from Operations for FY18 is ₹ 5767 cr, the EBITDA is ₹ 802 cr. EBIT ₹ 618 cr, PBT ₹ 147 cr and PAT ₹ 113 cr.

The FY18 saw a cumulative order inflow of ₹ 7666 cr and ended with the Order book backlog of ₹ 18622 cr.

For meeting its growth requirements, the company has raised in May 2018 ₹ 400 cr by way of QIP and ₹ 50 cr by way of allotment of share warrants to promoters.

Board has recommended a dividend of ₹ 0.50 per equity share of ₹ 2/- each for the year ended 31.03.18.
