- 1. The remote e-voting period remained open from 09:00 A.M. IST on Sunday, the 21st day of September, 2025 up to 5:00 P.M. IST on Wednesday, the 24th day of September, 2025.
- 2. The shareholders holding shares as on the "cut off" date, i.e. Thursday, the 18th day of September, 2025 were entitled to vote on the proposed 6 (Six) resolutions as mentioned in the Notice of the AGM dated the 13th day of August, 2025.
- 3. The Company had also provided e-voting facility at the AGM to enable the shareholders attending the AGM through VC / OAVM to cast the votes in case the same had not been cast by them through remote e-voting.
- 4. The votes were unblocked on Thursday, the 25th day of September, 2025 around 04:00 P.M. (IST) after the completion of the AGM in the presence of two witnesses, namely, Ms. Muskan Jaiswal, residing at 54/A, Nirmal Chandra Street, Kolkata 700 012 and Ms. Anushree Dasgupta, residing at 28/N, Dwijen Mukherjee Road, Behala, Kolkata 700 060, who are not in employment of the Company.
